What is OJS?

OJS is a program provided by Queen's Library for use by Queen's faculty and staff wishing to publish an online open-access or subscription-based journal. The service is offered free-of-charge.

OJS assists with every stage of the refereed publishing process, from receiving submissions through to online publication.

OJS was developed by the Public Knowledge Project (PKP) at the University of British Columbia, through its federally funded efforts to expand and improve access to research. The development is currently overseen by a partnership consisting of the PKP, the Canadian Center for Studies in Publishing and the Simon Fraser University Library.

The OJS platform is currently used in ten languages by over 2,000 journals around the world.

In addition to easy startup, OJS software takes full advantage of the online environment by providing readers with a range of search options. Readers can also browse journals by author, title or issue. Indexing occurs automatically as each issue is published.

Loaded with features

In addition to text, your OJS journal can include multimedia and links to external, related materials.

If desired, your journal can limit access to different levels of information within the journal, such as openly displaying the table of contents but limiting the full text of articles to subscribers.

Data stored within OJS is easily exportable, allowing for journal portability and integration with larger databases such as Scholar's Portal. This opens up the journal to a very large potential online readership.

OJS@Queen's provides up-to-date usage statistics to support applications for funding your OJS journal.

Alerts to newly published articles are available via email or RSS feeds.
