With reference to the above, please find below the reply pertaining to the Rajya Sabha provisionally admitted question Dy. No.U1679 for 09.07.2019 regarding **"Drinking water coolers in Hospitals"**

- a) *the number of patients who visited Government hospitals for medical treatment in Delhi, hospital-wise;*

Daily approximately 500-600 clients with communication disorders are availing diagnostic and therapeutic services at All India Institute of Speech and Hearing, Mysore

- b) *whether sufficient drinking water coolers are available and in working conditions in each hospitals; and*

We have four water coolers (with the capacity of 20 liters and 40 liters} in working condition. To cater to the increasing number of clients availing the services, installation of 250 capacity RO plant is planned and currently under process.

- c) *if so, how many coolers dispensing clean water to patients in each hospitals?*

Totally four water coolers meant only for patients are dispensing clean water.



With reference to the above, daily approximately 500-600 clients with communication disorders are availing diagnostic and therapeutic services at the Dept. of Clinical Services. Accordingly we have **two water** coolers, one in the first floor with the capacity of 20 liters and other in the ground floor with the capacity of 40 liters and both are in average working condition, which are insufficient for the present client load.

Thus, it has been proposed for the installation of 250 liter capacity RO water plant and it's under process.


