

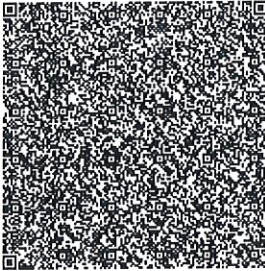

AND the VIVEKANANDA MEMORIAL HOSPITAL, Saragur, H. D. Kote Taluk, Mysuru District, Karnataka represented by its Secretary and Chief Executive Officer (hereinafter referred to as the **Second Party**) on the other, witnesseth as under:

WHEREAS, the AIISH, Mysuru (**First Party**) was established in the year 1965 and is an autonomous organization under the aegis of Ministry of Health & Family Welfare, Government of India, which is a premier institute providing training, research, clinical services and public education in the field of Speech and Hearing in the country, and

WHEREAS, VIVEKANANDA MEMORIAL HOSPITAL, Saragur, H. D. Kote Taluk, Mysuru District, Karnataka (**Second Party**) is a unit of Swami Vivekananda Youth Movement providing both medical and ayurveda services and has maternity & labor ward facilities, immunization & vaccination, Dental and AYUSH services, Integrated Counseling and Testing Centre (ICTC), Blood test facilities and eye care facilities,

WHEREAS, the AIISH, Mysuru (**First Party**) has undertaken to initiate NBS/Out-Reach Service (OSC) activities at the premises of the Second Party to accomplish the objectives of early Identification, Prevention and Management of communication disorders,

WHEREAS, to ensure smooth carrying out of Out-reach service activities effectively at VIVEKANANDA MEMORIAL HOSPITAL, Saragur, H. D. Kote Taluk, Mysuru District, Karnataka both the First Party and the Second Party have arrived at an understanding and have resolved to reduce in writing the broad outlines thereof, NOW THEREFORE, this Memorandum of Understanding witnesseth as here under:

1. The Second Party shall provide adequate space and the required Furnitures and Fixtures to carry out the screening, diagnostic and management activities and the minimum required facility in this regard shall be as under:

NBS program


- a) Silent space near maternity ward for testing
- b) One 10' x 10' electrically isolated room for ABR with sound treated facility
- c) 15' x 15' silent room for early diagnosis

Out-reach Service Center

- d) One double sound treated room for audiological testing & two silent rooms for assessment and rehabilitation.

2. The First Party (AIISH) shall recruit Audiologist / Speech-Language Pathologist (1 Nos.), Audiologist (1 No.), Speech-Language Pathologist (1 No) and Speech Hearing Assistant (02 Nos.) on contract basis to provide speech and hearing services in VIVEKANANDA MEMORIAL HOSPITAL, Saragur, H. D. Kote Taluk, Mysuru District, Karnataka

3. AIISH (First party) shall procure the equipments like pure tone audiometer, Immittance meter, OAE, ABR, (one each) and Speech- Language assessment tools and other tools / equipment required for the NBS and Out-reach Service activities and placed in VIVEKANANDA MEMORIAL HOSPITAL, Saragur, H. D. Kote Taluk, Mysuru District, Karnataka
4. The Second Party shall nominate /designate one of the regular staff members to supervise and monitor the clinical activities by maintaining good rapport with the Coordinator designated by the First Party,
5. The Second Party shall maintain the stock registers in respect of equipments procured by the First Party and spare and accessories, stationary and other materials purchased for carrying out the activities and produce for verification, as and when required.
6. The Second Party shall make a regular employee responsible / in-charge for maintenance of the stock registers by entering the details and conduct an annual physical stock verification of such equipments and send the report to the first party (AIISH, Mysuru).
7. The Second Party shall abide by any other guidelines / directions/ instructions that may be given by the First Party (AIISH) from time to time for efficient and smooth implementation of Out-reach Service activities.

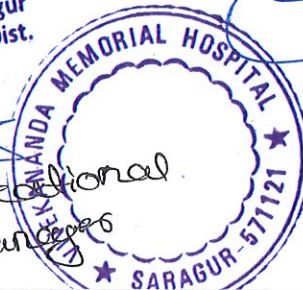
