JUDGMENT

Grievance of the petitioner is that, despite Ext.P4 order issued by the Government, which was ultimately confirmed by a Division Bench of this court in Ext.P6 judgment, the 4th respondent has not appointed her in the vacancy in question. Therefore, the relief sought for in the above writ petition is mainly to issue a direction to the 4th respondent to appoint the petitioner as directed in Exts.P5 and P6 judgments.

2. It is noticed that, when the writ petition came up for consideration on 5.4.2010, this court had issued an interim direction to the 4th respondent to appoint the petitioner with effect from the date when the school was reopened for the year 2004-05 and to forward the order of appointment for approval. Learned counsel for the 4th respondent submitted that, in view of the above direction the petitioner was already appointed and the above case has become infructuous.
