### ORDER

**WHEREAS** Shri Y.S Mallikarjunaiah, Security Officer, Quarters No. T3/103, Staff Quarters Complex, All India Institute of Speech and Hearing Manasagangothri, Mysuru, Karnataka – 570 006 had submitted an RTI application dated 22.01.2021 (received by PIO, BARC on 01.02.2021) requesting to provide the following information under RTI :

- (1) copy of vacancy register of ASO's from 2000 to 2003 & 2004,
- (2) copy of persons appointed as ASO's from 2000 to 2004,
- (3) copy of vacancy register & appointment register of ASO's giving the appointment made against each vacancy and
- (4) copy of the noting of the approval of his appointment as ASO/A.

2. **AND WHEREAS** the Public Information Officer has disposed of the RTI application vide RTI reply letter No. BARC/RTI/2021/02/5764/2041 dated 01.03.2021 exempting the disclosure of information sought at point Nos. (1) , (2) & (3) under section 8(1)(j) of the RTI Act, 2005 as the vacancy/appointment register contains personal details of individual employees such as their designation, date of joining/vacancy details, place of posting etc. As regards point No. (4), the query was transferred to PIO, RMP, Mysuru under section 6(3) of the RTI Act, 2005 as the information sought was not available in this Centre.

3. **AND WHEREAS** the said Shri Y. S. Mallikarjunaiah has preferred an appeal dated 18.03.2021, received by Appellate Authority, BARC on 25.03.2021 requesting to provide information/documents.

4. **AND WHEREAS** the undersigned as the Appellate Authority under RTI Act has called for the records related to this RTI application and it is seen that the RTI application was received by PIO, BARC on 01.02.2021 and the RTI application was replied vide RTI reply letter No. BARC/RTI/2021/02/5764/2041 dated 01.03.2021.


5. The point raised by the appellant are considered as under :

- i. As regards point Nos. (1) to (3) of the RTI application, Hon'ble CIC vide decision No. CIC/ACCGI/A/2017/163946 dated 07.06.2018 has mentioned that "the information in relation to the personal details of individual employee such as the date of his/her joining, designation, where he/she is posted etc., are personal in nature." Hence, exempt under section 8(1)(j) of the RTI Act, 2005.
- ii. As regards point No. (4) of the RTI application PIO, RMP, Mysuru vide RTI reply letter dated RTI/BARC(M)/01/2021/Sp-304 dated 16.03.2021 has requested the appellant to remit documentation charges for providing the available information.
- iii. The IPOs of ₹ 50/- and ₹ 100/- vide IPO Nos. 87G 003926 and 47H 111333 respectively were returned vide letter No. RTI/BARC/2021/5764/2445 dated 15.03.2021 as the same were not required.

6. Therefore, I uphold the decision of CPIO, BARC.
7. **AND NOW THEREFORE** the appeal of Shri Y. S. Mallikarjunaiah stands disposed of.
8. **Shri Y. S. Mallikarjunaiah** is hereby informed that in terms of Section 19(3) of RTI Act, 2005, a second appeal against the decision of Appellate Authority shall lie with the Central Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110 067 within 90 days from the date on which the decision should have been made or was actually received by the Appellant.
