WHEREAS Shri Y. S. Mallikarjunaiah, #58, III Cross, IIIrd Main, Bank Colony, Dff Ring Road, Bogadi, Mysuru, Karnataka – 570 026 had submitted an RTI application lated 21.12.2020 requesting to provide the details of employees recruited in 2004 under IPS (National Pension Scheme) and permitted to switch over to pension scheme, under IPS (Pension) Rules, 1972 with regard to Selection/Recruitment of Assistant Security Dfficer (A) personnel vide BARC Personnel Division, Recruitment Section III, Central Lomplex, Trombay, Mumbai vide Employment Advt. No. 1/2001-R-III, with Ref. to No. 1/2001-R-III/1282 dated 17th October 2002 for the period 2000-2002 and there inwards.

AND WHEREAS the Central Public Information Officer has disposed of the RTI ipplication vide letter No. BARC/RTI/2020/12/5684/937 dated 21.01.2021 stating that otal 07 persons recruited in the year 2004 have been permitted to switch over to Pension Scheme under CCS (Pension) Rules, 1972.

AND WHEREAS the said Shri Y. S. Mallikarjunaiah has preferred an appeal dated 1.02.2021 to the Appellate Authority, BARC requesting to provide the details of imployees recruited in 2004 under NPS (National Pension Scheme) and permitted to witch over to pension scheme, under CCS (Pension) Rules, 1972.

AND WHEREAS the undersigned as the Appellate Authority under RTI Act has alled for the records related to this case and it is seen that the RTI application was acceived by CPIO, BARC on 24.12.2020 and the RTI application was replied vide letter to. BARC/RTI/2020/12/5684/937 dated 21.01.2021.

On perusal of the records it is observed that CPIO, BARC has rightly provided ne information in numbers stating that 07 persons recruited in 2004 under NPS National Pension Scheme) and were permitted to switch over to pension scheme, under CS (Pension) Rules, 1972. Their name & other details of employees relates to ersonal information and disclosure would cause unwarranted invasion to the privacy of ne individual employee and hence exempt under section 8 (1) (j) of RTI Act, 2005. It is ertinent to mention here that the Hon'ble Supreme Court vide Order dated 31.08.2017 Civil Appeal No. 22 of 2009 held that the information relating to personal information f an individual employee such as joining, designation, details of promotion, transfer etc. which are not in larger public interest cannot be provided to a third party.

THEREFORE the appeal of Shri Y. S. Mallikarjunaiah stands disposed

fallikarjunaiah is hereby informed that in terms of Section 19(3) of RTI appeal against the decision of Appellate Authority shall lie with the n Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New ithin 90 days from the date on which the decision should have been ally received by the Appellant.
