Wole Adamolekun holds a doctorate in media arts from the University of Abuja, Nigeria. He has more than 30 years of practical industry experience in public relations and corporate communications. In addition to having published several scholarly articles worldwide, he is the author of *Public Relations Possibilities: Selected Seminars and Conference Papers* (2005) and a co-author of *Interactive Public Relations* (2007). Currently, he is General Manager of Corporate Services at the Petroleum Products Pricing Regulatory Agency in Nigeria. He is also Secretary General of the African Public Relations Association, based in Abuja, Nigeria.

Clifford G. Christians is the Charles H. Sandage Distinguished Professor and Research Professor of Communications at the University of Illinois, Urbana. He is Director of the Institute of Communications Research and Chair of the PhD programme, with joint appointments as Professor of Media Studies and Professor of Journalism. He received his PhD in communications from the University of Illinois and he has been on its faculty since 1974, where he has won five teaching awards. He has been a visiting scholar at the Department of Philosophy at Princeton University, a research fellow in social ethics and later a visiting scholar at the University of Chicago, and a PEW fellow in ethics at the University of Oxford. He is the author or co-author of eight books, including *Media Ethics: Cases and Moral Reasoning*, which is now in its eighth edition. His research and teaching interests are media ethics, communication theory and the philosophy of technology.

Stephen M. Croucher is an associate professor at the School of Communication and the Arts at Marist College in Poughkeepsie, NY. He researches immigrant assimilation, identity formation/negotiation within Europe and conflict management/conceptualization within the Muslim community. He is the winner of numerous top paper awards at regional, national and international conferences, has authored multiple journal articles on assimilation, religiousness and conflict within Islam, and has authored a book, *Looking Beyond the Hijab* (2008), on the Muslim community in France. He has also co-authored with Daniel Cronn-Mills his second book, *Religious Misperceptions: The Case of Muslims and Christians in France and Britain* (2010).

Gerard Elfstrom is Professor of Philosophy at Auburn University and received his doctorate from Emory University. He has authored books, chapters and articles in a number of areas, including the ethics of international relations, political philosophy, ethics, medical ethics, the philosophy of law, business ethics and the philosophy of science. His most recent books are *New Challenges for Political Philosophy* (1997) and *International Ethics: A Dictionary* (1998).

Melissa A. Johnson is an associate professor and Director of Graduate Studies in the Department of Communication at North Carolina State University. She holds a doctorate in mass communication research from the School of Journalism and Mass Communication at the University of North Carolina, Chapel Hill. Her research focuses on international visual communication, digital and traditional ethnic media, and public relations concepts related to Latinos, Latin America, technology and innovation. In addition to teaching at North Carolina State University, she has taught at the University of North Carolina at Chapel Hill, San Diego State University and Elon University, NC. She also has more than a dozen years of communication practitioner experience, including positions as Vice President of Corporate Relations for a California financial institution and Director of Public Relations for a top-ranked US school of public health. In addition, she has worked in a public relations agency and radio broadcasting.

Richard Lance Keeble is Professor of Journalism at the University of Lincoln. He has written and edited 13 books, including *Secret State, Silent Press: New Militarism, the Gulf and the Modern Image of Warfare* (1997), *The Newspapers Handbook* (2005, fourth edition) and *Ethics for Journalists* (2008, second edition). He co-edited *The Journalistic Imagination: Literary Journalists from Defoe to Capote and Carter* (2007) and *Communicating War: Memory, Media and Military* (2007), and is the joint editor of *Ethical Space: The International Journal of Communication Ethics* (www.communicationethics.net). His books have been translated into Chinese, Ukrainian and Romanian. His research interests include the journalism of George Orwell, the reporting of US and UK militarism, and the links between mainstream journalists and the intelligence services.

Élisabeth Le is Associate Professor of Applied Linguistics (French) in the Department of Modern Languages and Cultural Studies at the University of Alberta, Canada. Her research areas are pragmatics and (critical) discourse analysis. In her interdisciplinary work, she uses linguistic methodologies as some of the tools with which to study social

phenomena appearing through political, media and intercultural discourse. She has authored articles in the following journals: *Text*, *Journal of Pragmatics*, *Journal of Language and Politics*, *Discourse and Society* and *Études Internationales*. Her monograph *The Spiral of 'Anti-other Rhetoric'* (2006) explored the interconnections between media representations of the other and international relations. She is now working on how editorialists use sociocultural identities to participate in political debates.

Lara Lengel began her transnational and intercultural communication research when she was a Fulbright Scholar in North African Tunisia (1993–4). She is Chair and Professor at the Department of Communication, Bowling Green State University, Ohio, teaching MA and PhD-level coursework in communication and culture and in qualitative and humanistic research methods, undergraduate coursework in international communication, and communication and gender at both graduate and undergraduate levels. She is the author of a number of publications, including *Intercultural Communication and Creative Practice* (2004) and *Casting Gender: Women and Performance in Intercultural Contexts* (with John T. Warren, 2005), and numerous articles appearing in, among others, *Text and Performance Quarterly*, *Gender & History* and the *Journal of Communication Inquiry*. She has co-directed nearly \$500,000 of federal grant programmes funded by Fulbright, the US Department of State Middle East Partnership Initiative and the US Department of State Bureau of Educational and Cultural Affairs.

Alexander G. Nikolaev is Associate Professor of Communication in the Department of Culture and Communication at Drexel University, Philadelphia. He received his doctorate from the Florida State University where he also taught for four years. His areas of research interest and expertise include public relations, political communication, international communication, international negotiations, international news coverage and discourse analysis. He has years of practical work experience in the fields of journalism and public relations in the US and Eastern Europe. He has written a number of articles in these areas in trade and scholarly journals as well as some book chapters in the US and overseas. He is also the author of *International Negotiations: Theory, Practice, and the Connection with Domestic Politics* (2007) and co-editor of *Leading to the 2003 Iraq war: The Global Media Debate* (2006) with E. Hakanen.

Anna Kasafi Perkins is a Jamaican Catholic theologian who is former Dean of Studies and Lecturer at St Michael's Theological College,

He has held academic posts at Howard University (2005–6), Virginia Tech (1983–91) and Weber State University (1981–3). He holds doctoral and master's degrees from the University of Minnesota, Twin Cities. His research interests include international and strategic communication, ethics, public relations and health communication.

Terry L. Rentner is Associate Professor and Chair of the Department of Journalism in the School of Communication Studies at Bowling Green State University, Ohio. She teaches public relations and persuasion at undergraduate and graduate levels.
