
# **Institutional Repository Questionnaire Analysis**

The questionnaire was sent on Tuesday 8 April 2014 and the deadline for respondents was on Tuesday 22 April (2 weeks).


A total of 408 respondents filled in the questionnaire during this time.

## **Analysis of Replies**




5. In what format is your research preserved?






7. Do you own the copyright to your work?








10. Would you consider depositing publications yourself (self-deposit) or would you prefer mediated-deposit?






